Introduction

Computer/Internet access is available to employees in the district. Our goal in providing computer access to our employees is to promote educational excellence by facilitating resource sharing, innovation, communication, cooperation, and collaboration.

<u>Scope</u>

Internet access is provided by an Internet Service Provider under contract with the East Greenbush School District. With access to computers and people all over the world comes the availability of materials that may be considered to be inappropriate, unacceptable or possibly illegal or of no educational value in the context of the school setting. The East Greenbush Central School District has initiated reasonable safeguards to restrict access to inappropriate materials.

The connection to the Internet from the East Greenbush School System is being filtered by a proxy server. Employees who access or attempt to access inappropriate or illegal Internet sites may be identified through a filtering and monitoring system and may be subject to discipline, as defined in the East Greenbush Central School District Code of Conduct.

Terms and Conditions of this Acceptable Use Agreement

The signature indicates the party has carefully read and understood the terms and conditions of appropriate use.

- 1. <u>Acceptable Use:</u> The use of an assigned account must be in support of education, business, research and/or within the educational, professional developmental goals, roles, responsibilities and objectives of the East Greenbush Central School District. The use of personal electronic devices for educational purposes consistent with District policies and regulations is considered an acceptable use.
- 2. <u>Privileges:</u> The use of computer/Internet resources is a privilege, not a right.
- 3. <u>Network Etiquette:</u> Each account holder is expected to abide by the generally accepted rules of user etiquette. These rules include:
 - a. Be polite. Never send or encourage others to send abusive messages. Use appropriate language. You may be alone on a computer, but what you write, send, or receive can be viewed globally. Remember that you are a representative of your school and the East Greenbush Central School District on a non-private system.

- b. Do not use the district computer network in any ways that would disrupt network use by others. Use electronic mail appropriately. Do not send advertisements or solicitations, or things of that nature. E-mail is not guaranteed to be private. Everyone on the system has potential access to mail. Messages relating to or in support of illegal activities or inappropriate activities, as pertaining to this Use Policy, must be reported to the appropriate local principal/supervisor or system administrator.
- c. Do not reveal personal information, such as home address, phone numbers, passwords, credit card numbers, social security numbers or organization or team membership. This also applies to personal information about others.
- 4. <u>Unacceptable Network Use:</u> Transmission or receipt of any inappropriate material or material in violation of law or district policy, including but not limited to policy #4526, regulation #4526-R, policy #8630, and regulation #8630-R is prohibited. This also includes but is not limited to copyrighted material; threatening or obscene material; material protected by trade secrets; the design of or detailed information pertaining to explosive devices, criminal activities or terrorist attacks; sexism, sexual harassment or cyberbullying; pornography; gambling; illegal solicitation; racism; and inappropriate; commercial activities by individuals or for-profit institutions; use of product advertisement, or political lobbying. Illegal or inappropriate activities or activities of any kind that do not conform to the rules, regulations and policies of the East Greenbush Central School District are forbidden.
- 5. <u>Vandalism:</u> Vandalism is defined as any malicious attempt to harm or destroy property of the user, another user or of any other agencies or networks that are connected to the school district network or the Internet. Vandalism also includes, but is not limited to abusive overloading of data on the server, or the uploading, downloading or creation of computer viruses. Any engagement in network vandalism constitutes unacceptable use.
- 6. <u>Security:</u> Security on any computer is a high priority because of multiple users. Do not use another individual's account or log onto the system as the system administrator. If you identify a security problem, notify the principal/supervisor or system administrator.
- 7. <u>Updating:</u> If any information on your account changes (e.g., phone number, location or address), it is your responsibility to notify the system administrator.

STUDENT AGREEMENT FOR COMPUTER NETWORK USE

<u>Introduction</u>

<u>Scope</u>

The smooth operation and use of the network, including individual computers, relies upon proper conduct of the students who must adhere to strict guidelines, rules, and regulations. User agreements are designed so that students are aware of the responsibilities they take upon themselves. In general, their responsibilities necessitate acceptable, ethical, and appropriate utilization of the electronic network resources.

Internet access is provided by an Internet Service Provider under contract with the East Greenbush Central School District. - limit, suspend or revoke access to the school district network and/or Internet.
- 3. <u>Network Etiquette:</u> Each account holder is expected to abide by the generally accepted rules of user etiquette. These rules include:
