2. PLEDGE OF ALLEGIANCE

3. EX OFFICIO STUDENT COUNCIL COMMENTS AND PRESENTATIONS

A. Student Council Representatives: Ryan Seely-President; Emma Marchiony-Vice President

Ryan <u>Seely</u> reported that on March 24, 2022 students and staff will be wearing purple to raise awareness for Epilepsy. He said Student Council will hold a pizza fundraiser to raise money for that cause. He announced there will be a blood drive on Thursday, April 7, 2022 at Columbia High School and encouraged all eligible students and staff to donate blood. Ryan also said Student Council has planned a field trip to Six Flags New England to reward their members who have gone above and beyond the past few years, especially during the pandemic.

B. Bell Top Elementary School Bell Ringers Wall of Fame Ceremony

Mr. <u>Mahar</u> told the story of how the bell ringer award came about, and then presented the award to Assistant Superintendent Mr. James McHugh, former Bell Top principal for his leadership, dedication and contributions to Bell Top and the district at large with his academic leadership.

Ms. <u>Lussier</u> congratulated Mr. McHugh on becoming a Bell Top bell ringer. She stated during his ten years as Bell Top's principal he set expectations high while simultaneously supporting and encouraging students and staff to meet or exceed the levels of excellence he saw in them. She stated his balance of humor, compassion and genuine understanding of what it means to educate and care for children built a culture in the walls of the small community school that they all take great pride in.

Mr. <u>McHugh</u> thanked everyone for the honor and said he was truly touched, and that the ten years at Bell Top definitely stand out and are years he truly cherishes.

5. BOARD FORUM #1

Ms. <u>O'Brien</u> congratulated the students and staff who participated in Lion King Jr. at Goff for putting on a successful show. She also congratulated the students who had their art chosen for the High School Regional Art Exhibition at the Albany City Gallery. Ms. <u>Taylor</u> congratulated Mr. McHugh on his Bell Ringer recognition. Mr. <u>Yeboah</u> also congratulated Mr. McHugh.

6. PUBLIC FORUM #1

None at this time.

7. REPORTS AND PRESENTATIONS - SUPERINTENDENT OF SCHOOLS

Mr. Simons presented workshop #2.

He shared some highlights of the District: Sue Schreck, 5th grade teacher at Green Meadow recognized as a Master Teacher. Columbia High School graduation rate 98% Students in area Art shows and Drama performances Forty-four Sectional Titles and six State Championships Eight sportsmanship awards Twenty-two varsity athletes obtained 90% or higher GPA

He stated that since last week's presentation, Ms. Wager has adjusted both the revenue and expenditures sides of the budget, but the district is still working to bring the tax levy as close to zero as possible without cutting any needed programs. The Superintendent said the District will continue to work and make adjustments.

Mr. <u>Simons</u> explained the bus purchase reserve and stated the District would like to purchase eight buses at a cost of \$752,468. He explained the purchase of the buses is not from the general fund, but from a reserve voted on in 2018 by the community solely for the purpose of replacing buses. He stated that for every dollar spent to purchase a new bus, the District receives \$.68 back in transportation aid, which goes right back into the reserve for the next bus purchase.

The Superintendent proposed setting up a Capital Reserve similar to the bus reserve to defray the cost of construction, reconstruction and equipping of School District buildings and facilities, including original equipment, machinery, apparatus, appurtenances, furnishing, land acquisitions, and other incidental improvements and expenses. He explained the amount of the reserve fund cannot to exceed Five Million Dollars (\$5,000,000), inclusive of accrued interest and other investment earnings, over a term of ten (10) years. The Superintendent said funding of the Reserve Fund requires Board of Education Approval, and expenditure of Reserve Fund requires Voter Approval. Mr. Simons explained the District has maintained the reserves, even through difficult times and since the reserve will be used instead of borrowing, it saves the local taxpayers.

Mr. Buono asked if the capital project and reserve would need to be voted on in separate votes by the community.

Ms. <u>Simons</u> said yes, that is how it works, but that if the reserve didn't pass, the Board could always propose to lower the cost of the capital project.

Mr. Buono asked if the reserve could be used for other purposes, such as machinery, or equipment.

Ms. Wager said only if the machinery or equipment are included in the capital project, such as HVAC or technology.

Mr. <u>Mann</u> stated he would like for the District to bring the tax levy down to zero percent. He said since Assemblyman McDonald stated last week that this year's state aid is the best available, he hopes the District will be able to meet that goal.

Ms. Skumurski thanked Mr. Simons for the presentation, and said she supported the Capital reserve.

Ms. O'Brien asked if the reserves weren't used, does the money go back into the general fund.

Ms. <u>Wager</u> explained at the end of its term, the money can be used to pay down debt, or go back into the general fund to reduce the levy. She stated you could also open a new reserve and transfer the balance.

Mr. <u>Dunn</u> expressed his concerns over offering a zero tax levy again this year and stated he would rather have a slight gradual increase now to avoid a large increase later.

Ms. Cannon presented the 2022-2023 draft calendar to the Board.

B. Update on Pre-K Planning

Ms. <u>Wager</u> announced that the District will be offering Pre-K to residents in three locations in the upcoming school year; Red Mill Elementary, Donald P. Sutherland Elementary and Citizen Genet Elementary. She stated that 18 slots will be available in each school. Ms. <u>Wager</u> explained that a lottery will be held on April 11, 2022 for the available spots.

Mr. Buono said he fully supports this program and he thanked Mr. Alvey and Mr. Grignon for carving out space within their schools for the program.
