B. Genet Elementary School Board Recognition Memo

Mr. <u>Grignon</u> welcomed everyone to Genet Elementary School. He said he was honored to host the Board appreciation meeting, and thanked the Board members for their many volunteer hours working to put together wonderful programs for the students. Mr. <u>Grignon</u> showed a cute video he and his staff put together, asking the students what they think the Board of Education does. Next, the fifth grade class sang "Thank You for Being a Friend". Mr. <u>Grignon</u> concluded the program by thanking the Board members for being a friend to the East Greenbush Central School District, and noted that all their tireless efforts are what make the District a wonderful place to work, and a wonderful place for the children.

Mr. Buono thanked the fifth grade chorus, and commented on how much the Board enjoys seeing the children.

C. Mary P. VanDerzee Special Educator of the Year Award - Presented by the Special Needs Parent Support Group, Kara Herrington & Bill Coyle

Mr. <u>LaGoy</u> announced that it was time to present the Mary Van Derzee Special Educator of the Year Award on behalf of the Special Needs Parent Support Group. The Award is in honor of Mary Van Derzee, a Director of Pupil Personnel Services at the District from 1988-1992. Subsequently, Ms. Van Derzee worked in the Office of Disabilities at the College of St. Rose from 1993-2003. Ms. Van DerZee is honored for her advocacy efforts on behalf of students with disabilities. The award winner is inscribed on a plaque that is displayed in the employee's building during the school year.

Mr. <u>LaGoy</u> introduced Ms. McDonald and Ms. Maciol, chairs of the advisory group for parent's of students in the special education program, for the award presentation.

Ms. <u>McDonald</u> recognized Ms. Elizabeth Corey for all her work with children over the last nine years. Ms. <u>McDonald</u> and Ms. <u>Maciol</u> told their stories of how Ms. Corey worked with their daughters Melena and Amelia. They described her work and dedication, and said their children have thrived with Ms. Corey's guidance, and are now ready to graduate in 2023. Melena and Amelia also spoke about how Ms. Corey helped them, and continued to support them throughout the years.

Ms. Corey thanked everyone for the recognition, and said how much she enjoyed teaching and making a difference in students lives.

4. MINUTES

Approval of the minutes was postponed to the November 9, 2022 meeting due to lack of a quorum.

5. BOARD FORUM #1

Ms. Skumurski thanked everyone for the presentations.

6. PUBLIC FORUM #1

Mr. Anson Miaski, parent and alum, spoke about his support of the eighth grade Washington trip, and said he hoped the trip could happen again this year.

7. REPORTS AND PRESENTATIONS - SUPERINTENDENT OF SCHOOLS - 7:35-7:50

A. Board of Education Appreciation

Mr. <u>Simons</u> thanked the Board members for their continued support and service to the community. He acknowledged the difficult decisions that the Board must make, and stated that they always make choices that continue to support what is best for the students, the District and the community as a whole.

Mr. Buono thanked his family for their support, and noted that seeing all the positive activities is very rewarding.

B. Capital Project Planning - Update on Discussions Related to CHS Access Road

Mr. <u>Simons</u> reported that he and other administrators have recently met with representatives of the Town of East Greenbush, and the owners of the Mannix Road Tech Park to discuss a secondary access road for Columbia High School. He explained the owners of the Tech Park are willing to allow emergency access, but the District would like more permanent access. Mr. <u>Simons</u> reported Regeneron has recently purchased some of the property abutting the District, and the District has reached out to their representatives for further discussions. He noted that these meetings are very preliminary, and he isn't sure if there can be some type of easement or if the District will need to include the development of the road into a capital project.

8. DISCUSSION ITEMS

A. Board Goals

Mr. Simons provided the strategic vision for 2022-2023:

- Support innovative, future-driven teaching, learning and leadership practices which prepare students with the knowledge and skills they require for future success
- Meet the academic, social-emotional, cognitive, mental health, and trauma-based needs of ALL learners
- Promote practices which support a safe, welcoming culture where ALL children, families and employees feel they belong and
 experience success

He asked the Board to review the goals and provide comments, questions and ideas. He said he hoped to get these goals finalized and adopted by the end of November.

Mr. <u>Buono</u> noted he had worked with Mr. Simons and Mr. Stiles on the new goals, building on the one's from last year. He said this gives the Board a look forward, a guiding point to help get to the things they would like to accomplish as a District. He said continuing the partnerships and building relationships with the community and families is really important.

- Ms. <u>Skumurski</u> commented that the team did a great job summarizing the goals and making it as direct and clear as possible.
- Mr. Simons asked them to review the goals and share their thoughts, as this was just a draft version.
- Mr. Mann asked if they were changing the wording from goal to strategic vision.
- Mr. Simons said they used the term because this is more of a three to five year mission.
- Mr. Buono said they can be more specific on the scorecard with goals or steps they would like to complete this year.

Mr. Mann said he didn't want to lock into something for 3-5 years, when every year things can change and the direction of the Board may also change.

Mr. <u>Simons</u> explained that the scorecard process will still occur, and there will still be an annual review of the goals. He said there will be flexibility to adjust and make modifications to align with the Board's direction.

B. 2023-2024 Proposed Budget Calendar and District Vote

Ms. <u>Wager</u> explained the dates in preparation for the May 16, 2022 vote. She explained there are two calendars, both the same, but one is in chronological order for easier reading.

She explained that the budget hearing would need to be held 7-14 days prior to the vote, so she would like to hold the budget hearing and board meeting on May 3, 2022, instead of the scheduled May 10th board meeting. She also discussed changing the location from Goff Middle School gymnasium to a location with better acoustics.

Mr. Buono said he thought the Genet auditorium is a good place to hold the public hearing.

Ms. Steinbach said the Board should be mindful of the holiday Ramadan, which occurs in March.
